E-Filing User Guide

This is a User Guide to e-filing in the Trumbull County Court of Common Pleas, General Division. It is intended to be a quick reference for users navigating the e-filing system. It is not a replacement for the Local Rules and/or the current Administrative Order governing e-filing. All users should read the Local Rules and the current Administrative Order and familiarize themselves with the same in order to understand the specific e-filing rules and requirements contained therein.

- 1. All users must register with the Trumbull County Clerk of Court in order to utilize the e-filing system. Users must establish an electronic payment method in order to register.
- 2. All documents must be filed in PDF format.
- 3. All motions MUST include a proposed order USING THE PROVIDED PROPOSED ORDER TEMPLATE titled

"PROPOSEDORDERTEMPLATE.docx".

Users will need to insert the case information in the caption as well as paste the body of their proposed order. USERS SHALL NOT ALTER THE SIGNATURE TOKEN FOR THE JUDGE'S SIGNATURE IN ANY MANNER WHATSOEVER.

4. All registered users will be required to maintain an active password and may be prompted to change their password from time to time in accordance with security procedures.
